## SAN GIACOMO DOG PARK MEMBERSHIP AGREEMENT

Anyone using the Park shall do so at their own risk. Dogs MUST wear Municipality Dog License Tag. The Town of New Windsor shall have no liability for injury or damage to the dogs or people using the Park. Any information is provided solely to assist residents in safely using the Park and does not imply an expertise or acceptance of any liability on the part of the Town of New Windsor.

Permittee hereby WAIVES ANY RELEASES AND ALL CLAIMS for damages that may arise from permittees use of the San Giacomo Dog Park against the Town of New Windsor, its officers, employees, agents, security or animal control personnel (all of whom are hereinafter referred to collectively as 'THE RELEASEES') and I hereby waive any and all liability for any loss, damage, expense or injury including death that I or my pets may suffer DUE TO ANY CAUSE CLAIM, OR UPON ANY THEORY WHATSOEVER, INCLUDING CLAIMS FOR NEGLIGENCE,

Premises Liability, ADEQUACY of Supervision or any OTHER CAUSE OF ACTION OR THEORY.

Permittee hereby agrees to DEFEND, INDEMNIFY AND HOLD HARMLESS the Town of New Windsor and all RELEASEES from all costs, damages, suits, claims of any kind brought by another by reason of Permittees use of San Giacomo Dog Park pursuant to this permit, and to do so to the fullest extent of the law.

#### SAN GIACOMO DOG PARK

#### **PLEASE KEEP THIS PAGE FOR YOUR REFERENCE**

1. Permittees are limited to a maximum of two (2) dogs per permittee at any one time.
2. The safety of all dogs is the responsibility of their owners and **NOT** the Town of New Windsor.
3. Aggressive dogs **MUST** be immediately removed from the park by their owners or handlers.
4. Small dogs and large dogs should be separated in their respective areas.
5. All dogs must be on a leash until inside the fenced area.
6. All dogs **MUST** be properly licensed.
7. All dogs **MUST** be fully vaccinated.
8. All owners or handlers must be over the age of 18.
9. No food of any kind is permitted inside the dog park.
10. It is the responsibility of each dog owner to clean up after their dog.
11. Permittees are prohibited from bringing guests or providing access to the park for others.
